
Promote circular and sustainable consumption.



lapajarita THE BRAND AS **A GUARANTEE OF PRODUCT SAFETY**

All the products manufactured by La Pajarita are used in contact with food, so safety rules are a priority for us.

La Pajarita products guarantee that the safety standards and raw material with which they are manufactured comply with the relevant laws and regulations. We consider and evaluate the intended use of the product and obtain third party certificates to meet all certifications.



The easiest way to find out if a product is suitable for food contact is to look for this symbol with a fork and a cup. It is used on all products intended to come into contact with food.



For your designs and personalizations, La Pajarita uses ecological inks based on natural vegetable oils and water-based inks. They are inks that reduce the environmental impact of printing processes, also minimizing the percentage of chemical components used in product manufacturing.



The raw material for all La Pajarita products is **FSC** certified, which certifies that the wood from which the product is made comes from forests managed according to criteria of the "Forest Stewardship Council" which includes, among other things, measures of sustainable forest management in ecological, social and economic aspects.



The **Ecolabel** label is also known as the European Ecological Label. It is a system that aims to help European consumers easily identify products that are organic and environmentally friendly.



The recycling symbol, with a "100%", specifies the percentage of recycled material in the product being purchased.



The decomposable logo certifies the biodegradability and decomposability characteristics of the product according to EN13432 standard.



The **Zero Waste** certification verifies the traceability of waste and verifies the percentage of recycling, valuation or recovery of waste in relation to the total production process.
